

PROHIBITED ITEMS LIST

THE FOLLOWING IS A LIST OF ITEMS THAT ARE NOT PERMITTED WHILE AT SPIRITLIFE. THIS LIST IS NOT FINAL, AND ADDITIONAL ITEMS MAY BE CONFISCATED UPON INTAKE AT THE DISCRETION OF SPIRITLIFE STAFF IF DEEMED NOT CONDUCTIVE TO RECOVERY.

- 1) WEAPONS OF ANY KIND (EX: KNIVES, SHARP OBJECTS, GUNS)
- 2) NARCOTICS OF ANY KIND (EX: POWDERS, LIQUIDS, PILLS)
- 3) OVER THE COUNTER MEDICATIONS (EX: IBPROFEN, ASPRIN, TYLENOL, MELATONIN, OR OTHER SUPPLEMENTS UNLESS ADMINISTERED AND APPROVED BY NURSING STAFF)
- 4) TOBACCOS RELATED ITEMS
 - a. OPEN TOBACCO PRODUCTS INCLUDING CHEW (SNUFF), CIGARETTES, CIGARS, TUBES, BAGS OF TOBACCO, AND PRE-ROLLED CIGARETTES
 - b. ALL TYPES OF VAPORISORS (VAPES) AND ELECTRONIC CIGARETTES
 - c. CLIENTS MAY BRING A ONE SEALED BAG OF TOBACCO OR ONE CARTON (10 PACKS) OF SEALED CIGARETTES.
- 5) ALCOHOL RELATED ITEMS
 - a. MOUTHWASH CONTAINING ALCOHOL
 - b. HANDSANITIZERS
 - c. WIPES CONTAINING ALCOHOL
- 6) AEROSOL SPRAYS OF ANY KIND
- 7) HYGIENE/BEAUTY RELATED ITEMS
 - a. 5 MAKE UP ITEMS (NO LOOSE POWDERS, OR BROKEN PRESSED POWDER ITEMS, BROKEN COMPACT MIRRORS WILL NOT BE ALLOWED) COSMETIC ITEMS WILL BE MARKED WITH YOUR INITIALS UPON ADMISSION.
 - b. WIGS (UNLESS NEW AND SEALED IN THE PACKAGE)
 - c. STRAIGHTENER, CURLING IRON
 - d. ANY PERMANENT OR TEMPORARY HAIR DYES OR COLOR RINSES
 - e. PERFUME, COLOGNE, AFTERSHAVE, AND BODYSPRAYS (ANYTHING GIVING OFF A STRONG SCENT)
 - f. NAIL POLISH, NAIL POLISH REMOVER, NAIL GLUE, AND FAKE NAIL SUPPLIES, NAIL STRENGTHNER
 - i. YOU WILL NOT BE ABLE TO REMOVE NAIL POLISH/REMOVER AND/OR SCENTED SPRAYS FROM CONFISCATION
- 8) ELECTRONIC RELATED ITEMS
 - a. RADIOS, ANYTHING WITH A RADIO BUILT-IN THE ITEM, CD PLAYERS, TAPE PLAYERS/RECORDERS, IPODS, CDS OR DVDS
 - b. ALARM CLOCKS WITHOUT RADIOS ARE PERMITTED
 - c. ELECTRONIC READING DEVICES (EX: KINDLES, IPADS)
 - d. LAPTOPS, TABLETS, NETBOOKS, AND SMART WATCHES
 - e. VIDEO GAME CONSOLES, VIDEO GAMES, OR ANY ELECTRONIC GAMES (EX: XBOX, WII)
 - f. CELL PHONES, PAGERS, AND ANY CHARGERS
 - g. CAMERAS AND VIDEO RECORDERS
 - h. ELECTRONIC TOUTHBRUSHES; BATTERY OPERATED OR CHORD CHARGED

- i. CLIENTS MAY BRING THEIR OWN FANS-THEIR NAME MUST BE ON THEM IN PERMANENT MARKER.
- 9) GAMES OR CARD GAMES OF ANY KIND; MAINLY PLAYING CARDS. (SPIRITLIFE PROVIDES DOMINOES, CERTAIN CARD GAMES, AND OTHER BOARD GAMES)
- 10) LIGHTERS
- 11) PORNOGRAPHIC MATERIALS: MAGAZINES, VIDEOS, DVDS, AND PICTURES
- 12) HIGH-VALUE, EXPENSIVE ITEMS (EX: JEWELRY, CASH)
 - a. CLIENTS WILL ONLY BE ALLOWED TO CARRY \$20 ON THEM AT ANY TIME. ANY ADDITIONAL MONEY WILL BE STORED IN THE SAFE WITH BALANCE SHEET
- 13) FOOD & DRINK RELATED ITEMS
 - a. DRINK MIXES (EX: CRYSTAL LIGHT, MIO)
 - b. CHOCOLATE, SOFT CANDY (EX: GUMMIES, TAFFY), AND CHEWING GUM
 - c. ONLY HARD CANDIES ARE PERMITTED
 - d. PROTEIN BARS, PROTEIN SHAKES, OR ANY OTHER SUPPLEMENTS; INCLUDING MELATONIN
 - e. ANY OPENED OR UNOPENED PACKAGES OF OUTSIDE FOOD (EX: CHIPS, COOKIES, DRINKS, ETC.)
- 14) LINENS (EX: BEDDING, TOWELS, BLANKETS, PILLOWS)
- 15) STUFFED ANIMALS
- 16) CLOTHING RELATED ITEMS
 - a. LAUNDRY DETERGENT, FABRIC SOFTENER, LAUNDRY PODS, AND DRYER SHEETS
 - b. CLOTHING THAT ADVERTISES ALCOHOL, PORTRAYS DRUG PARAPHERNALIA, PROMOTES DRUG CULTURE, DEPICTS NUDITY, OR STRONGLY SUGGESTS DRUG-RELATED CONTENT (EX: 420, BOB MARLEY)
 - c. CLOTHING THAT IS DEEMED TOO REVEALING, SEXUALLY SUGGESTIVE, OR INAPPROPRIATE.
 - i. SHORT SHORTS: MUST BE FINGERTIP LENGTH
 - ii. TANK TOPS-SHIRTS SLEEVES MUST COVER THE ENTIRE SHOULDER
 - iii. MESH PANELS, SEE-THROUGH, OPEN-BACK, HALTER TOPS, STOMACH REVEALING CLOTHING, AND JEANS (PANTS) WITH EXCESSIVELY LARGE TEARS/RIPS
 - iv. SPIRITLIFE STAFF WILL USE DISCRETION IN DETERMINING THAT AN ARTICLE OF CLOTHING IS DEEMED INAPPROPRIATE
- 17) WALLETS, PURSES, SMALL BAGS, AND BACKPACKS (THESE ITEMS WILL BE KEPT IN THE CONFISCATION CLOSET UNLESS OTHERWISE DEFINED AND DOCUMENTED)
- 18) CUPS, MUGS, THERMOSES, OR CONTAINERS TO HOLD LIQUIDS OR ANY LIQUID HOLDING CONTAINER
- 19) CLIENTS ARE ALLOWED TO HAVE 1 SPIRITUAL BOOK, 1 RECOVERY BOOK, AND 1 NEW COLORING OR PUZZLE BOOK. BOOKS WILL BE SUBJECT TO CONFISCATION BASED ON DISCRETION OF STAFF.
- 20) ART MATERIALS (PUZZLE BOOKS, COLORING BOOKS, COLORING UTENSILS, ETC.) ARE SUBJECT TO STAFF DISCRETION. CRAYONS, COLORED PENCILS, OR REGULAR PENCILS MUST BE SEALED IN THEIR ORIGINAL PACKAGING, ORDERED IN, OR PROVIDED BY SL. CLIENTS ARE NOT PERMITTED TO HAVE PAINT, PAINT MARKERS, GLITTER, OR GLITTER GLUE PENS. ANY ART MATERIALS CAN BE CONFISCATED AT STAFF DISCRETION
- 21) TAROT CARDS ARE PROHIBITED
